SAMSUNG WASHING MACHINE SMOL PROMOTION (“PROMOTION”)
TERMS AND CONDITIONS

Participants agree to be bound by these terms and conditions (the “**Terms and Conditions**”). Any information or instructions published by the Promoter about the Promotion at <https://smolproducts.com/samsung> form part of the Terms and Conditions.

The Promoter

1. The promoter is Samsung Electronics (UK) Limited, Samsung House, 1000 Hillwood Drive, Chertsey, Surrey, KT16 0PS (the “**Promoter**”).

Promotion Period

2. The Promotion will commence at 00:01 (GMT) on 24 July 2019 and shall close at 23:59 (GMT) on 15 October 2019 (the “**Promotion Period**”).

Eligibility

3. To be eligible to participate in the Promotion you must be a resident (aged 18+) in the UK or ROI, hold either a valid debit or credit card in order to register with Smol. (“**Participant**”).
4. Employees or agents of the Promoter or anyone professionally connected to this Promotion and any group company of the Promoter is not eligible to enter.

Offer

5. Participants who purchase a new (i.e. not second hand) Samsung washing machine (a “**Promotion Product**”), from Argos during the Promotion Period will be entitled to claim 72 washing capsules free from Smol by redemption (the “**Reward**”).
6. Rewards are non-transferable and there is no cash alternative. In the event of unforeseen circumstances, the Promoter may substitute a Reward of equal or greater value for the Reward.
7. The Reward may be redeemed alongside any Smol introductory trial period that may be available when first accessing Smol.
8. If Participants do not cancel the subscription immediately on receiving order confirmation of their third pack in the free trial, the Smol subscription will automatically renew at the standard pricing per order (a minimum of £3.85).

Claims

10. To claim the Reward Participants must then at any time before 23:59 (GMT) on 23 January 2020 (the “**End Date**”):
 - a. Access Smol at <https://smolproducts.com/samsung>;
 - b. Click the “Get Started” button and sign up for a ‘free trial’;
 - c. For new Smol customers, create a new account by registering credit/debit card information. For existing Smol customer, create a new plan;
 - d. In the “Order summary” section enter your product’s unique serial number, **removing the last letter from the end**, in the ‘Do you have a code?’ section. This should be a 14 digit code. Click “Continue” and enjoy 72 Smol capsules for free (“**Claim**”).

For the avoidance of doubt, the Claim entitles the Participant to 72 capsules free of charge. The Participants must pay a £1 postage fee but will not be required to make any further payment until after the free trial.

11. Claims made after the End Date will be marked as invalid and will not be accepted.
12. Participants may submit a maximum of one (1) Claim per Promotion Product

General
